Description

The contract owner has the authority to mint tokens. The owner may take advantage of it by calling the mint function. As a result the contract tokens will be highly inflated

Recommendation

The owner should carefully manage the credentials of the owner's account. We advised considering an extra-strong security mechanism that the actions may be quarantined by many users instead of one. The owner could also renounce the contract ownership for a period of time or pass the access to the zero address.



Tegro Token is an interesting project that has a friendly and growing community. There are some functions that can be abused by the owner, like minting new tokens after initial deployment. A multi-wallet signing pattern will provide security against potential hacks. Temporarily locking the contract or renouncing ownership will eliminate all the contract threats.
